A regular meeting of the Somerset Township Board of Supervisors was held on Wednesday, July 10, 2024, at the Township Municipal Building. The meeting was called to order at 6:00 p.m. with the following in attendance: Supervisors James Bockstoce Joseph Cole Mark Lohr

PUBLIC COMMENT

Tom Kalchthaler suggested the supervisors are not concerned for their jobs or not being re-elected with the ordinance changes they are voting on tonight and asked that they reconsider.

Bill Pollock advised that the Township is not required to update ordinances and that he is only objecting to allowing business in agriculture zoning district as 80% of the Township is agriculture. Mr. Pollock also stated he was given minimal time as Planning Commission Chairman to review the proposed revisions and that the proposed changes were done in private. He is also concerned with traffic and tax increases and is petitioning for a supervisor board increase from three to five members.

Mike Lehotsky is not in support of proposed changes. He stated the board should listen to residents rather than take advice from a consulting group and solicitor. He also recommends board members abstain from voting to avoid conflict of interest concerns.

Mike Ornot asked if financial item on agenda were advertised and stated that residents can pay for waterline. Billy DeBlasio asked for supervisors separate opinions on the proposed ordinance changes.

Dan Smith asked why employees are allowed overtime. Cole advised it is for road issues after hours.

Greg Spridik stated that there is a difference at the Township in the last five years. He advised the supervisors are elected to represent the residents and to assist them and that is no longer the case. He stated the current ordinance updates process was hidden and should have followed the way of the Bayer property update.
